TAMPA MEETING PREVIEW

Agenda Item #3, Management Committee and Commission Consideration of Adoption of the Amendments to Address Colorado Statutory Conflict with Suicide Exclusion Provisions: The proposed amendments to address the Colorado statutory conflict with suicide exclusion provisions will be considered for final action. The Management Committee and Commission extended the written comment due date to December 2, and the Briefing Sheet and Transmittal Memo have both been updated to clarify that these proposed changes will apply prospectively to new business as of the effective date. Both documents can be found on the <u>Compact's online</u> <u>Docket</u>.

Agenda Item #4, Management Committee and Commission Consideration of Adoption of the Framework and of Operating Procedure for the Use of Compact-Approved Products for other than Employer Groups: This item, if adopted, will permit the use of Compact-approved group products for non-employer groups, with Compacting states retaining the authority to approve or disapprove a non-employer group according to the respective state laws. The Rulemaking Committee has proposed changes to the Operating Procedure and Framework based on submitted comments. Please see the <u>Compact's online Docket</u>.

Agenda Item #5, Management Committee and Commission Consideration of Adoption of the Proposed 2023 Annual Budget and Schedule of Fees: The action item is to consider for adoption the proposed 2023 Annual Budget and Schedule of Fees. The Finance Committee recommended these items in September and the Management Committee held a public hearing at the November 15th meeting. An increase to the product filing fees is being proposed to the Schedule of Fees and no additional staff is being requested for 2023. The associated documents can be found on the Events page of the Compact's website.

Agenda Item #6, Management Committee and Commission Consideration of Adoption of the Proposed 2023 Uniform Standards Development Prioritization: The action item is to consider for adoption the proposed 2023 Uniform Standards Development Prioritization to drive the Product Standard's Committee's 2023 work plan. The associated documents can be found on the <u>Compact's online Docket</u>.

Agenda Item #7, Report of the Audit Committee and Consideration by the Commission to Adopt the Report of the Audit Committee: The Audit Committee will provide a report on its activities.

Agenda Item #8, Management Committee Consideration of Appointments to the Industry Advisory Committee and Consumer Advisory Committee: The action item is to consider the recommendation of the Compact Officers for appointments to four expiring seats on the Industry Advisory Committee and to open seats on the Consumer Advisory Committee. A more detailed memo will be sent to Commission members in advance of the meeting.

Agenda Item #9, Commission Consideration of the Formation of Insurance Compact Management Committee and other Committee Assignments: The action item is formation of the Management Committee based on Article III, Section 1 of the Commission Bylaws and the recommendation of the Compact Officers for appointments/ assignments of Commission member committees. A more detailed memo will be sent to Commission members in advance of the meeting.



DOCKET UPDATE

On Nov. 15th, the Management Committee voted to expose the draft Individual Disability Income Buy Sell Insurance and Individual Disability Income Key Person Replacement Insurance Uniform Standards for public comment. The drafts were developed by the Product Standards Committee based on the Individual Disability Income Business Overhead Expense Uniform Standard with modifications for the unique features of the Buy-Sell and Key Person Replacement products.
