ACLI indicated that some companies currently use the purchase rates that are described in Section 3.T.(4)(b) of the Individual Deferred Paid-Up Non-Variable Annuity Contract Standards in their administrative systems and pricing models for Individual Immediate Non-Variable Annuities. For consistency purposes, the industry is requesting that the same option be provided under the Individual Immediate Non-Variable Annuity Contract Standards.
