2. Status report on the Employer Group Whole Life Uniform Standard Subgroup

Explanation: A subgroup of PSC members is meeting weekly on the Employer Group Whole Life Insurance Uniform Standard draft. There will be an oral report on the progress of the subgroup.

3. Status report on the Index-Linked Variable Annuity Uniform Standard subgroup.

Explanation: A subgroup of the PSC will be meeting weekly to review draft Index-Lined Variable Annuity Draft Uniform Standard. There will be an oral report on the progress of the subgroup.

4. Review proposed changes to expand the scope of Single Premium Group Annuity Contract Uniform Standards for Employer Groups

Explanation: The PSC determined the scope of this Uniform Standard would need to be amended to allow products other than for Pension Risk Transfers. This item is included in the Annual Prioritization of Uniform Standards Development for 2023. The Compact Office presents an initial draft of proposed changes to this Uniform Standard to permit other fixed group annuity contracts for further discussion by the PSC.
